1. Introduction

Other Information: If voluntarily provided (e.g., through feedback forms, surveys, or social media interactions), we may collect additional information such as guest remarks, preferences, and special requests.

3. How We Use the Information

We use the information we collect for the following purposes: - To process bookings, transactions, and attendance at our facilities and events. - To send confirmation emails, updates, newsletters (where consent is given), and customer service communications. - To improve, maintain, and personalize our website, services, and user experience. - To analyze website usage, measure traffic, and monitor trends. - To send promotional offers and updates, unless you opt out. - To comply with legal obligations and protect the rights, property, or safety of Coastal Wilds, our visitors, staff, or animals.

4. How We Share Information

We do not sell your personal information. We may share information in the following circumstances: - With service providers and business partners who assist with payment processing, email communications, bookings, or website hosting. These parties are contractually obligated to protect your data. - With legal authorities if required by law, regulation, or valid legal request, or to protect the rights, property, or safety of Coastal Wilds, our visitors, or others. - In a business transfer, such as a merger, acquisition, or asset sale. We will notify you if your personal information becomes subject to a change in ownership or use. - With your consent or at your direction.
